To Apply

Interested candidates should contact Rena Olson at rena@yakonaoregon.org. All docents are required to participate in an orientation training and attend bimonthly meetings.

Position Overview and Responsibilities - Yakona Access Docent

Under the direction of the Community Arts and Engagement Manager, the Yakona Access Docent will assist with public access to Yakona Nature Preserve.

- meet visitors at the gate and escort them in;
- provide guests with an orientation for visiting Yakona;
- guide them on nature and/or history walks on property trails;
- ensure visitors are safe and knowledgeable of the guidelines for visiting Yakona

Position Overview and Responsibilities - Yakona Habitat Docent

Under the direction of the Forest and Lands Manager, the Yakona Habitat Management Docent will assist with habitat management, restoration, and stewardship at Yakona Nature Preserve.

- meet volunteer groups at the gate and escort them in;
- provide visitors with an orientation to the property;
- obtain training in the use of tools and equipment;
- conduct all activities under the guidance of Yakona staff.

Position Overview and Responsibilities - Yakona Naturalist Docent

Under the direction of the Community Arts and Engagement Manager, the Yakona Naturalist Docent will assist with educational programs at Yakona Nature Preserve.

- meet school groups and other visitors at the gate and escort them in;
- provide students, teachers, and chaperones with an orientation to the property;
- obtain training in educational activities and behavior management techniques;
- oversee a group of children, leading them through educational programming;
- provide behavior management of children as appropriate;
- ensure visitors are safe and knowledgeable of the guidelines for visiting Yakona.

Youth Protection Policy

In accordance with Yakona's Safety Plan and Youth Protection Policy, fingerprint-based criminal history checks of all staff and docents are required if they work with youth. Yakona will be responsible for the fees associated with this requirement.

Yakona Nature Preserve was created to restore, protect, and steward remnant spruce-dominated coastal rainforest on Oregon's Yaquina Bay. The Preserve is named for the Yaqo'n, original inhabitants of the land.
